

Always allow NEWLY MOUNTED WHEELS to run at operating speed, with guard in place, for at least one

minute before grinding.

Always TURN OFF COOLANT before stopping wheel to avoid creating an out-of-balance wheel.

Storage: No special storage conditions required.

Hygiene Practices: Wear suitable gloves and eye/face protection.
